## TEN (10) YEAR LIMITED PRODUCT WARRANTY EXPLANATION

The enclosed properly completed Warranty Request Form is required by UNITED COATINGS in order for the **Ten (10) Year UNI-TEX Warranty** to be issued:

### 1. The Warranty:

This Warranty is a guarantee **to the Building Owner** that the **UNI-TEX** coating system will not leak water over a 10-year period due to deterioration as the result of ordinary weather conditions. This Warranty is not to be used for any other purpose unless specifically approved in writing by an officer of UNITED COATINGS.

### 2. Warranty Request Form:

- A. When the job is completed, the Approved Applicator must submit the Warranty Request Form to UNITED Headquarters for issuance of the Warranty.
- B. The properly completed Warranty Request Form by the Approved Applicator certifies the application to be in accordance with UNITED'S current published application instructions.

A. United Coatings warrants to the Building Owner that for a period of 10 years from the date of completion, UNI-TEX applied per UNITED COATINGS' current specifications to any area of sound and properly prepared above-grade masonry, concrete, exterior grade sheathing, or expanded polystyrene (EPS) board will perform as follows:

1. UNI-TEX products as described in published literature shall be free from manufacturing defects for the full warranty period.
2. UNI-TEX will be water-resistant for the full warranty period.
3. UNI-TEX will not peel, flake or chip for the full warranty period.

B. If during the Warranty period, any such failure occurs resulting from ordinary weather conditions in any area that UNI-TEX has been properly applied, UNITED COATINGS agrees to supply to the Applicator at no charge all UNITED material needed to repair such affect area(s).

C. This Warranty is expressly conditioned upon:

1. The Applicator having a valid "Certified Applicator" certificate\*.
2. The Applicator's obligation to apply UNI-TEX in a good and workmanlike manner, and in strict accordance with UNITED'S current published instructions covering surface preparation, application and precautions.
3. The Applicator's obligation to notify UNITED COATINGS in writing within seventy-two (72) hours of the date that the Owner notifies Applicator of any defect, failure or deficiency which is covered by this Warranty. UNITED COATINGS shall then have the right to immediately inspect the defect, and if not given this right the Warranty shall be terminated.
4. The understanding that UNITED COATINGS shall not be responsible for repairs made by others not authorized to make such repairs.

D. This Warranty does not cover failure of UNI-TEX due to the following::

1. Damage to the UNI-TEX caused by fire, settlement, structural cracks or defects, faulty construction, movement, mis-use of structure, or other failure of the structure.
2. Cracks, breaks, or openings in the substrate to which UNI-TEX is applied.
3. Surface alterations, additions, objects placed or installations made in the finished surface.
4. Damage to UNI-TEX due to natural causes, including but not limited to floods, lighting, hail, windstorms, cyclones, hurricanes, tornadoes, earthquakes or other extraordinary or unusual events.
5. Use of UNI-TEX on anything other than vertical wall.
6. Improper preparation of the substrate.
7. Sealant failure or water penetration due to leaks through windows, air conditioning units, holes, louvers, vents, or other elements that cause water penetration (such as leaking rain gutters which have been incorporated into the system, improper flashing, lack of proper flashing, etc).
8. Vandalism, penetration or damage caused by third parties or foreign objects or agents, including plant or animal life.
9. Discoloration or change in visual appearance due to accumulation or streaking of dirt or other airborne materials deposited on the surface from the atmosphere.

E. If the UNI-TEX Applicator fails to make payment to UNITED COATINGS and/or its Distributor, this Warranty shall be void.

F. This Warranty is for the benefit of the initial purchaser, and shall not be transferable or assignable to any other persons, firms or corporations without prior express written consent by an officer of UNITED COATINGS.

G. UNITED COATINGS will not be liable for any direct, indirect, consequential, special or general damages of any kind from whatever cause may arise as the result of deterioration of said coating, except to supply all UNITED COATINGS' material in accordance with the Warranty. It is expressly understood and agreed that UNITED COATINGS shall in no way be deemed or held to be obligated, liable or accountable upon or under any guarantees or warranties, express or implied, including any implied Warranty of merchantability or fitness for a particular use or otherwise beyond this express Warranty.

H. This Warranty in not effective unless executed by an officer of UNITED COATINGS, the Approved Contractor and the Owner.

\*The Certified Applicator Certificate indicates that certain employees of the Contracting Firm have been approved by UNITED COATINGS and/or UNITED'S Distributor to apply the UNI-TEX products and have received copies of UNI-TEX Application Instructions and Specifications. The Certified Applicator Certificate does not indicate that UNITED has apprenticed or endorsed the Applicator. Each Certified Applicator is an independent company, experienced in the trade, and bears responsibility for its own workmanship. UNITED COATINGS assumes no liability for the workmanship of any Certified Applicator.
